#### SetUp

Setup is from 6am to 9am the day of the event. Please allow enough time to have your display or booth set up and staffed by nine. **You will not be allowed to unload on park grounds after 9:00 am.**

#### Vehicles

Vehicles are not allowed on the park grounds except to deliver products or displays during setup and tear down times. Vehicles must be off the grounds once products and displays are delivered. Driving areas will be clearly marked at the event location. To help ensure the event starts on time, **all vehicles must be off the grounds by 9:00am and are not allowed back on the grounds until 4pm.**

#### All Vendors Excluding Food Vendors

Each organization/vendor is required to have an activity or give-away that supports the Literacy and Arts theme.

**Cancellation** A two-week written notice is required for cancellations. There will be a \$25.00 cancellation fee. \$50.00 if notice is less than two weeks.

#### Clean Up

Participants are responsible for cleaning their area. All displays must be removed from the grounds the day of the event.
